The Center for Evidence to Practice (the Center) was created in 2018 to increase statewide access to evidence-based programs (EBPs) that address key behavioral health needs for Medicaid-insured children and families in Louisiana. These efforts are accomplished in collaboration with the Office of Behavioral Health (OBH) and Louisiana Medicaid.

THE MISSION

The Center's mission is to partner with OBH to support children's behavioral health providers, organizations, and communities in the selection and implementation of evidence-based and research-driven models that promote youth and family well-being, improve behavioral health outcomes, and address challenges related to sustaining quality practice.

THE EBP PARTNERSHIP









HIGHLIGHTS OF 2022 EBP INTERACTIVE MAP GROWTH

HIGHLIGHTS OF 2022 EBP TRAINING OVERVIEW DATA

The Center's certified, in-state trainers provide courses in Youth PTSD Treatment (YPT), Preschool PTSD Treatment (PPT), Trauma-Focused Cognitive Behavioral Therapy (TF-CBT), Parent-Child Interaction Therapy (PCIT) and Eye Movement Desensitization and Reprocessing (EMDR). Each new training cohort is recruited through a Request for Applications (RFA) process. Accepted trainees are selected according to their qualifications, availability to successfully complete the course, and their access to resources to the implement services.


EMDR Provider Employment Status (%) Both 2022 Cohorts

EMDR License Type (%) Both 2022 Cohorts







TF-CBT License Type (%) Both 2022 Cohorts




TF-CBT Demographic Overview by Age Fall 2022 Cohort Only, N=29


PCIT Provider Employment Status (%) Both 2022 Cohorts




PPT/YPT Provider Employment Status (%) Both 2022 Cohorts




RESEARCH INFORMED PRACTICE PROVIDER DATA FAMILY INTERACTION TRAINING (FIT)



RESEARCH INFORMED PRACTICE PROVIDER DATA HUMAN TRAFFICKING (HT) INTERVENTION







CAPACITY & SUSTAINABILITY FUNDING OPPORTUNITY

The Center **completed the EBP Capacity and Sustainability (C&S) initiative** awarded \$167,500 to providers who achieved EBP qualifications, integrated EBP tracking codes within claims processes, and demonstrated delivery of EBP services.


C&S Participant Overview

Financial Impact


30 providers were provided additional funding:


- 16 providers were awarded funding
