TF-CBT Web 2.0

The Medical University of South Carolina has an online course "[TF-CBT Web 2.0](#)", which is a part of the overall training process to become certified in TF-CBT. These online modules provide a comprehensive foundation of the evidence-based TF-CBT model.

As completion of TF-CBT Web 2.0 is a requirement for national certification, the Center for Evidence to Practice is making this a prerequisite for participating in a learning collaborative.



Instructions

- Register for TF-CBT 2.0 by the Medical University of South Carolina.
 - *This course costs \$35. The Center for E2P is not sponsoring the cost of this online requirement at this time.*
- **Once you complete the 11-hour course, email your certificate of completion to EvidencetoPractice@lsuhsc.edu**
- Upon receiving your certificate, the Center for E2P will send you a certificate for **11 CEUs** for Louisiana social workers and counselors.

Kelly, our TF-CBT trainer, requires completing the TF-CBT Web training before the first learning session. It will provide you with a foundation in TF-CBT to build on, and many practitioners who have trained through the Center for E2P stated that it was incredibly helpful.
