### **Target Population Characteristics**

Clinicians working with clients across the lifespan who have been maltreated, abused and neglected.





#### Philosophy and Treatment Approach

- Understanding childhood trauma and trauma across the lifespan creates emotional and psychological deficits.
- The approach is to identify the events that have taken place in a person's life in order to resolve these events.
- What is more important is to resolve the defensive responses to these events that are now causing the person problems in the present.

# **Application Training Criteria**



<u>Training acceptance criteria for qualified behavioral health</u> <u>agencies/providers:</u>

- ➤ Who serve Medicaid-insured individuals and/or provide clinical therapy services to children and their caregivers in Louisiana, free of charge
- Licensed (or actively working towards licensure)
- ➤ Actively (currently) treating children and their caregivers
- Preference for organizations that have multiple practitioners applying to be trained



## **Training Population**


- Applicants need to be actively working with clients and have an interest in or would benefit from the content of this course.
  - Clinicians do not need to have prior training or experience working with trauma-related disorders.

#### **GOAL:** Provide Foundational Knowledge

- This training is **not an EBP training**, it is a research-informed training.
- This training provides a starting point for those who have **not yet** participated in an EBP training such as EMDR or TF-CBT.
  - ➤ Provides foundational knowledge in trauma before proceeding with a more advanced training (i.e. EMDR and/or TF-CBT).

#### **Training Commitment**


- ➤ Upon selection, all applicants will be required to complete a Training Commitment between the applicant and the Center.
