# Facilitators of Training Completion

---

- Peer support
- Supervisor and administration support
- Agency is trauma-informed
- Well-established referral pipeline
- Commitment to consultation and learning the model
- Relationship with consultant

# Barriers to Training Completion

---

- Case identification and selection
- Therapist reluctance to proceed
- Clients don't attend consistently
- Therapists don't attend consultation calls consistently

- Caseload adjustment
- Referral pathways
- Website/Advertisement of Services

---

1. ~~Attend PPT/YPT Training Day: Monday, March 16, 2026, 8:30am-4:30pm, 1-day virtual training~~ ✓
2. Attend **weekly 1-hour group consultation calls**, present case and receive consultation *in process*
3. Complete **one (1) PPT and/or YPT case**. *discussion*
  - If you complete a case with a child **3-6 years old**, you will receive a certificate of completion for Preschool PTSD Treatment (PPT) Advanced Training.
  - If you complete a case with a youth **7-17 years old**, you will receive a certificate of completion for Youth PTSD Treatment (YPT) Advanced Training.

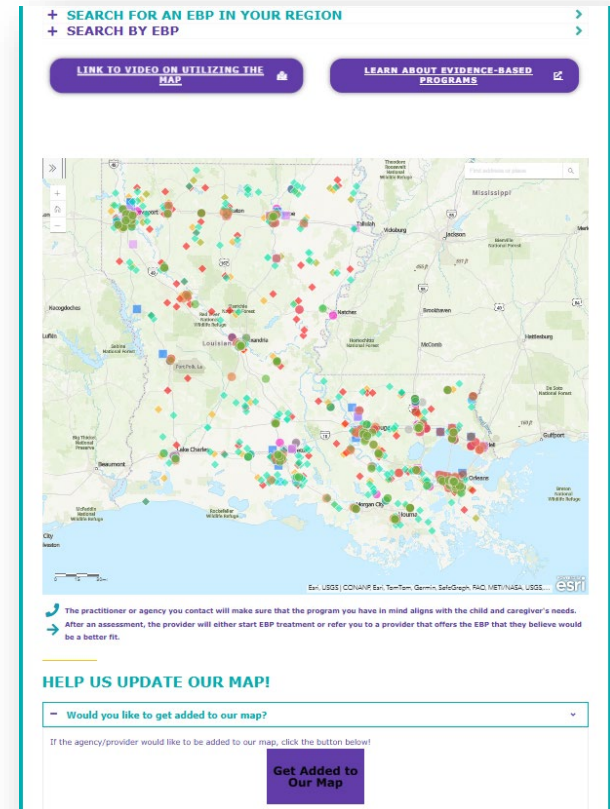

Certificates of Completion of Advanced Training in Youth PTSD Treatment and/or Preschool PTSD Treatment issued by Tulane University School of Medicine OR inclusion on the registry of PPT / YPT certified providers having completed Advanced Training.

## **Additional Information**

The YPT / PPT trainer issues the certificate upon completion of the training and consultation requirements for Advanced Training and maintains a registry of all certified providers

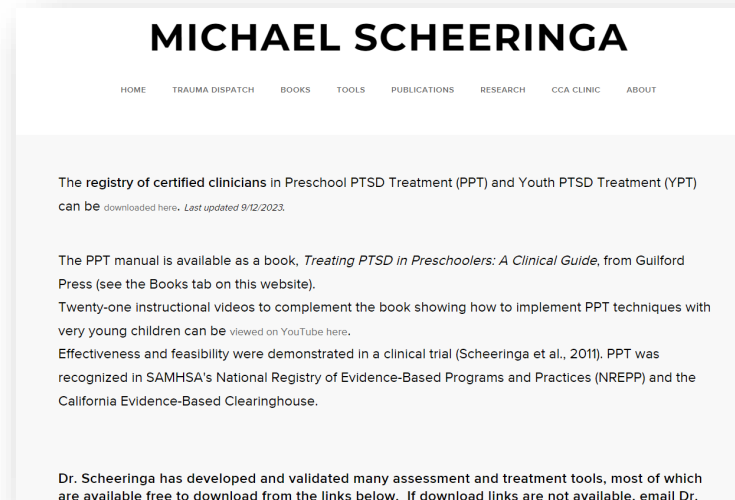
